ABAI 48th Amual Convention: Safely Reunited In Boston

We are thrilled to be hosting an in-person event again after two years away. Boston will provide a historically and culturally rich setting for over 450 hours of symposia, panels, invited talks, and more.

The 2022 Society for the Advancement of Behavior Analysis (SABA) Awards highlights the tremendous contributions made to behavior analysis by Deisy de Souza (Distinguished Service to Behavior Analysis), Martha Hubner (Effective Presentation of Behavior Analysis in the Mass Media), Stephen Higgins (Scientific Translation), The Carbone Clinic/Vincent Carbone (International Dissemination of Behavior Analysis), and Drake University (Enduring Programmatic Contributions in Behavior Analysis).

The program includes two thematic tracks this year: one on supervision and one on ableism. A complete list of the presentations in this track can be found on pages 14-17.

The 2022 Presidential Scholar Address, "Giant Rats to the Rescue! Applied Principles Shape Behaviors and Communities," will be given by Dr. Cynthia Fast, Head of Training and Innovation at APOPO, a Belgian NGO that trains African giant pouched rats for scent detection of humanitarian targets. She will discuss the training of these rats to detect buried landmines and tuberculosis. Her complete abstract can be found on page 20.

The B. F. Skinner Lecture Series—presentations organized by the Program Board and area coordinators and delivered by non-behavior analysts who work in complementary fields—will provide convention attendees with a sense of how behavior analytic findings and methods contribute to broader scientific topics including human trafficking, ethical animal training, gun violence, and systemic racism in child health. Invited presentations will highlight some of the field's most important and interesting leaders and trends. This year, the convention will feature presentations on diversity, equity, and equality, cannabis, obesity, stimulus



equivalence, maternal health interventions, social justice, animal welfare, relational frame theory, and operant conditioning. A complete list of invited presentations can be found on pages 10–19.

The Professional Development Series is an initiative of the ABAI Student Committee, which invites panels to address topics of special interest to Student members. Topics at this year's conference include cultural humility, starting a psychotherapy clinic, developing time management, and finding mentorship.

The program includes 294 panels and symposia, 75 workshops, 67 invited presentations—including 17 B. F. Skinner Lectures—and over 500 posters. Opportunities to collaborate and learn about other programs and organizations will be found during 36 business meetings, 24 reunions and receptions, and the Expo poster session, with over 120 posters.

Convention Attendee Services

As over 5,000 members from 30+ countries join us in Boston, we invite you all to review and explore ABAI services for attendees:

- At this time, in accordance with city of Boston regulations, we are not requiring proof of vaccination to attend the convention. We understand the importance of everyone's safety and will pay close attention to all CDC/ city of Boston updates and immediately announce any changes to this policy. Regardless of vaccination status, all attendees and staff will be required to wear masks while indoors for the duration of the convention. SABA Awards

The Society for the Advancement of Behavior Analysis (SABA) provides financial support for the field of behavior analysis. As a 501(c)(3), nonprofit organization, SABA accepts tax-deductible donations, distributes donations through grants and fellowships, and recognizes leaders in behavior analysis with its annual awards ceremony.

Award for Distinguished Service to Behavior Analysis Deisy de Souza

(Universidade Federal de São Carlos) Deisy de Souza is Full Professor at the Psychology Department, Universidade Federal de São Carlos (UFSCar), Brazil, where she teaches behavior analysis in graduate and undergraduate courses in Psychology, and in Special Education. She obtained her Ph.D. in Experimental Psychology at Universidade de São Paulo (USP), under the direction of Carolina Bori, and she held Deisy de Souza a post-doctoral position at the University

of Maryland Baltimore County, in Charlie Catania's Laboratory. She has published articles on avoidance behavior, choice, discriminative learning, and cooperative behavior in non-human subjects, and articles, books, and book chapters on human relational learning, including studies applying the stimulus equivalence paradigm to investigate the acquisition of symbolic relations involved in reading and writing repertoires, and to develop curricula to teach those skills. She is past-editor of the Brazilian Journal of Behavior Analysis (BJBA), past-associate editor of Acta Comportamentalia, and she is currently a member of the Board of Editors of the Journal for the Experimental Aanalysis of Behavior. She was president and member of the Council of the Brazilian Association of Psychology and member of the Brazilian Association of Psychology and Behavioral Medicine. She received the 2015 Distinguished Contributions to the Experimental Stephen Higgins Analysis of Human Behavior Award from the Experimental Analysis of Human Behavior Special Interest Group (EAHB SIG), she is a

Fellow of the Association for Behavior Analysis International (ABAI), and she is currently the International Representative in the ABAI Executive Council and in the SABA Board of Directors.

Award for Scientific Translation

Stephen Higgins

(University of Vermont)

Stephen T. Higgins, Ph.D., is Director of the University of Vermont's Center on Behavior and Health, and Principal Investigator on multiple NIH grants on the general topic of behavior and health, including an NIGMS Center for Biomedical Research Excellence (COBRE) award, a NIDA/FDA Tobacco Centers of Regulatory Science award, and a NIDA institutional training award. He is the Virginia H. Donaldson Endowed Professor of Translational Science in the Departments of Psychiatry and Psychological Science. He has held many national scientific leadership positions, including terms as President of the College on Problems of Drug Dependence and the American Psychological Association's Division on Psychopharmacology and Substance Abuse. He has received numerous national awards for research excellence including a 2001 NIH-MERIT Award (NIDA), 2001 Don Hake Basic/Applied Research Award (Div 25, APA), 2011 Brady-Schuster Award for Outstanding Behavioral Science Contributions to Psychopharmacoloy or Substance Abuse (Div 28, APA), and a 2017 Mentorship Award (College on Problems of Drug Dependence). He is the author of more than 425 journal articles and invited book chapters and editor of a dozen volumes and therapist manuals in behavior and health.

Award for Effective Presentation in the Mass Media

Martha Hübner

(University of São Paulo) Martha Hübner is a full professor at the University of São Paulo, Brazil, in the Department of Experimental Psychology. She had her undergraduate course at Catholic





University of São Paulo (1979), her master's and doctorate degrees in Experimental Psychology at the University of São Paulo (1982 and 1990, respectively). She is a former president of the Brazilian Association of Psychology (SBP; from 2002 to 2005), of the Brazilian Association of Behavioral Sciences (ABPMC; from 2008 to 2011), and former President of the Association for Behavior Analysis International (ABAI; 2014 to 2017). She also served on the Executive Council of ABAI from 2009 to 2014 as elected International Representative. She is a researcher at Drake University the National Institute of Science and Technology in Behavior, Cognition, and Teaching (INCT-ECCE) in Brazil. Hübner has published 68 papers, 40 book chapters, four books and given around 130 speeches about behavior analysis in Brazil and around the world, disseminating behavior analysis. In May 2018, she received the Award for "International Dissemination of Behavior Analysis," granted by ABAI.

Award for International Dissemination Vincent J. Carbone

(Carbone Clinic)

Dr. Vincent J. Carbone is a Board Certified Behavior Analyst-Doctorate and New York State Licensed Behavior Analyst. He received his graduate training in behavior analysis at Drake University and a doctorate in education from Nova-Southeastern University. He ecurrently serves as an adjunct faculty member at Penn State University and previously taught in the graduate programs in Behavior Analysis at the European Institute for the Study of Human Behavior (IESCUM), in Parma, Italy, and at the Medical School at the University of Salerno, Salerno, Italy. His behavior analytic research has been published in several peer-reviewed journals including the Journal of the Experimental Analysis of Behavior, Journal of Applied Behavior Analysis, The Analysis of Verbal Behavior, Behavior Modification, and others. He has provided the requisite university training to hundreds of board certified behavior analysts in the U.S. and internationally. He is the 2017 recipient of the "Jack Michael Outstanding Contributions in Verbal Behavior Award" from the Association for Behavior Analysis International's Verbal Behavior Special Interest Group. Currently, he serves as the director of the Carbone Clinics in London, UK and Dubai, UAE. All clinics provide behavior analytic consultation, training and therapeutic services to children and young

adults with autism and developmental disabilities. The Carbone Clinic is the 2022 recipient of the Society for the Advancement of Behavior Analysis (SABA) award for "International Dissemination of Behavior Analysis". Dr. Carbone currently serves as a member of the board of directors of the B. F. Skinner Foundation.

Award for Programmatic Contributions

The history of the behavior analysis program at Drake University is long and has undoubtedly experienced a nonlinear path over the last 50 years. Scott Wood, Kenneth and Maggie Lloyd were instrumental in initiating the Master's program at Drake University in 1974. Four new positions that were added in 1974 were filled by behavior analysts including William Klipec and Larry Alferink in the experimental analysis of behavior (EAB), and John Williams and Maryann Powers in applied analysis of behavior (AAB). Through the seventies the program earned a strong national reputation for excellence in both EAB and AAB with an additional specialists' degree in school psychology. During this time, in the mid to late 70s, the department, and its faculty, was a prime mover in the organization of Midwestern Association of Behavior Analysis (MABA) and the separation from Midwestern Psychological Association (MPA), which ultimately lead to the formation of the Association of Behavior Analysis (ABA; later added International; ABAI). Despite the contributions to the field, the weight of factors that contributed to its success ultimately led to the demise of the program during the late 80s. Nonetheless, the department continued its emphasis on behavior analysis and continued to send undergraduates to doctoral programs in behavior analysis developed in the 80s. Through the 2000's, faculty in the program have worked to address the need for behavior analysts within Iowa with faculty holding leadership positions within the Iowa Association for Behavior Analysis. Their contributions led to licensure within the State of Iowa for behavior analysts and professional recognition by the Board of Educational Examiners thus continuing to impact the landscape of the profession on a broader scale. Dr. Klipec will expand upon the history of the department describing the height of the program and the pressures faced at a small liberal arts institution.

Some Thoughts About the Future: Science, Culture, and Values Monday, May 30, 6:00 pm-6:50 pm

Ruth Anne Rehfeldt (The Chicago School of Professional Psychology, Chicago)

Ruth Anne Rehfeldt received her Ph.D. from the University of Nevada, Reno in 1998, and is a professor at the Chicago School of Professional Psychology, Chicago and Director of the Center for Autism Spectrum Disorders. Dr. Rehfeldt has contributed both basic and applied research that is impressive for its bench-to-bedside translation in the area of derived stimulus relations. Particularly

Ruth Anne Rehfeldt noteworthy is her applied work demonstrating the effectiveness of interventions based on derived stimulus relations for learners ranging from young children to persons with disabilities to graduate students. Her work has contributed to the understanding of complex forms of human behavior, focusing on verbal behavior, rule governance, observational learning, stimulus equivalence, and perspective-taking. Dr. Rehfeldt has also served on a number of editorial boards and was editor of The Psychological Record for more than a decade.

Abstract

In his seminal paper "Some Thoughts About the Future" (1986), Skinner delineated directions that he thought were critical for the experimental analysis of behavior to take in order to thrive in the future. Now seems to be a fitting time to reflect upon the ways in which behavior analysis as a discipline can flourish in the years ahead, particularly in light of the world's recent sociocultural challenges. Skinner long envisioned that the science of behavior would mature sufficiently to be effectively applied at the level of a culture, where mechanisms of selection could be implemented in ways that supported the well-being of all members and the longevity of the group. I contend that a science of cultural behavior may be well poised to promote cultural change if synthesized with the research program and conceptual framework supplied

by relational frame theory (RFT), and applied methods drawn from these innovations that help create a science of intentional change. In this presentation, I explore how cultural practices are selected and transmitted not only by direct-acting contingencies, but also due to the influence of verbal stimulus functions, or indirect acting contingencies. I provide examples from such diverse topics as political propaganda or rhetoric and prejudice and stigma. I further explore how acceptance and commitment training (ACT), scaled up and applied at a systems level, may be able to alter the functions of verbal stimuli so that cultural practices consistent with a community's shared values can be established. Planning for the future requires a behavior analytic conceptualization of values, which has been traditionally defined as the reinforcers that maintain a culture's practices. Challenges persist in arranging contingencies whereby people value not only the well-being of others but their culture's future as well. RFT helps behavior analysts appreciate valuing as a verbal process, whereby statements of values enhance the efficacy of reinforcers for behaviors consistent with those values. This approach can help us develop a technology for promoting shared or collective values among communities of people, to include, for example, celebrating diversity, promoting the well-being of others, and caring about the future. Although the primary purpose of this address is to serve as a call to action for the broad-scale application of RFT and ACT to propel a behavior analytic science of cultural change, I conclude by suggesting that the discipline itself engage in something akin to values clarification to ensure that our field adapts to changing circumstances and shifts paradigms so that the field itself has longevity. We may not have time to waste.



2022 ABAI Presidential Scholar's Address:

Giant Rats to the Rescue! Applied Principles Shape Behaviors and Communities Saturday, May 28, 6:00 pm-6:50 pm

Cynthia Fast (APOPO)

Dr. Cynthia Fast is the Head of Training and Innovation at APOPO, a Belgian NGO that trains African giant pouched rats (Cricetomys ansorgei) for scent detection of humanitarian targets. Cindy has more than twenty years of experience training a variety of animals, including rats, mice, pigeons, and hermit crabs, in addition to family cats, dogs, birds, and horses. She holds a Ph.D. in psychology from UCLA where her research focused on comparative cognition and behavioral neuroscience. While a member of the Behavioral and Systems Neuroscience department at Rutgers University, she investigated the neurobiology of rodent olfaction including how learning influences olfactory sensation and perception. Her research has received numerous professional awards, including the prestigious James McKeen Cattel Gold Medal from the New York Academy of Sciences. She is a member of the Pavlovian Society, Society for Neuroscience, Women in Learning, Association for Chemoreception Sciences, and Comparative Cognition Society and has served as a mentor in both Women in Learning and the STEM Alliance Next Scholars program.

Abstract

Adopting fundamental principles of behavior, the Belgian NGO, APOPO, developed a hero out of the most unlikely of creatures, the African giant pouched rat (Cricetomys ansorgei). The rats are native to Tanzania where they have historically been viewed as pests. APOPO established operational headquarters in Tanzania in 2000 to train the rats to use their keen sense of smell for locating buried landmines in former conflict zones. Landmines not only pose serious safety and psychological risks, they also hamper economic development by blocking access to agriculture and displacing communities. To date, APOPO's rats have safely located more than 140,000 landmines and unexploded ordnances (UXOs) to help return more than 65 million m2 of safe land to local

communities in Africa and Southeast Asia. Research that began in 2003 has successfully trained the rats to also detect tuberculosis (TB). Until recently, TB stood as the world's deadliest infectious disease. Working in partnership with local health authorities in Sub-Saharan Africa, TB-detection rats screen upwards of 100 sputum samples from suspected TB patients in under 20 minutes. To date, the rats have efficiently identified more than 20,000 patients that had otherwise been misdiagnosed, effectively increasing case detection by 40%. Ongoing research continues to inform training techniques by revealing the universal nature of behavioral principles. For example, recent results suggest interventions developed to prevent extinction in scent detection dogs and laboratory rats may reduce the need for routine maintenance training of deployed landminedetection rats. Applying standardized training procedures in additional lines of research provides insights for optimizing how the rats are deployed and where. Recent results show they can be trained to detect other pathogens posing health and economic risks, contribute to various environmental initiatives by detecting contaminated soil and illegally trafficked wildlife, and even support search and rescue efforts following natural disasters. Through the process of training scent detection rats, APOPO's collective work continues to shape behaviors, perspectives, and livelihoods.

Introducing Our Tiered Model of Education

The Association for Behavior Analysis International's (ABAI) new Tiered Model of Education offers recognition of quality academic training programs. The Tiered Model is based on the ABAI Accreditation Board standards (Tier 1) and includes four main tiers, or levels, of recognition, leading toward ABAI accreditation. Programs in Tier 1 are accredited by the ABAI Accreditation Board and have achieved the highest level of quality recognition in behavior analysis. Tiers 2a through 4b specify approximations to ABAI accreditation, taking into consideration different programmatic structures and offerings. Given the range of program capabilities and structures that exist internationally, the tiers offer recognition of quality training by those programs not able to meet the accreditation standards. At the same time, the tiers offer a road map for programs that aspire to eventually seek accreditation. All programs are evaluated according to the same standards with considerable flexibility in the way research

and practical training are handled, the structure of the program, and with regard for applicable laws, regulations, and cultural environments.

The tiers are organized by three factors: whether the program is housed in an institution of higher education, whether it produces academic degrees, and whether it includes supervised experiential learning. A non-degree program, also referred to as a certificate or post-graduate program, is generally a coursework-only program that does not result in an academic degree or diploma.

Remembering Michael Dougher

"Dr. Michael Joseph Dougher, of Albuquerque, 71, passed away on Saturday, December 18, 2021. He died doing what he loved—winning at pickleball." *

He was the first child of Joan (Beiss) and Raymond Dougher. His family moved to Los Angeles, California when he was five and he spent his formative years surfing, playing football, working at a hot dog stand, and getting kicked out of numerous Catholic schools."

Thus began one of his obituaries. To everyone who knew him, his death came as a stunning shock. How could so viable a spirit be gone?

In 2017 one of us (JM) had the pleasure of introducing him at his ABAI presidential address. We hope this introduction captures some of that spirit:

"Dammit! Some guys really do have it all—looks, super smarts, wit, charm, the athletic prowess of a black diamond skier, an equally-talented and beautiful wife, Kathy, who also happens to be trained as a professional chef, a beautiful home in Albuquerque over-looking the Rio Grande, and God-knows what other treasures. Having known Mike for many years, he continues to surprise me with the depth of his knowledge and the range of his skills.

As Mike begins his address to you in a moment, he will become the 39th ABAI President and few, if any, have come to this office with more sterling credentials for inspired leadership than he.

Trained initially as a clinician at the University of Illinois, Chicago and ascending the academic scale at the University on New Mexico through a unique and integrative combination of basic and applied research in clinical behavior analysis and in complex stimulus control, as well as through outstanding, award-winning teaching. His work in transfer and transformation of function through equivalence and relational frames is definitive. I would add for most of us who find some of this work mind-bogglingly complex, in both methodology and presentation, his studies are among the most lucid and compelling in the literature. He is a master of thoughtful clarity. I heard him give an address in Brazil a few years ago on ACT and it was the first time I (and I suspect most of the rest of his audience) understood what this movement was all about and why it was important.

But wait, there's more. Let's face it folks, no matter how eminent (and certainly Mike is), most professors are utterly unsuited to the challenges of administration in the shark tanks of academe. Not so Mike. His multiple talents and passion for scholarship and, especially, the advancement of science—basic and applied—propelled him from Department Chair, to Associate Dean for Research, to Associate Vice President, to Senior Vive-Provost for Academic Affairs, to Vice President for Research. In over 40 years of attendance at these meetings, I personally have known no one who has stood before this gathering awaiting his ABAI presidential address with such gifts and accomplishments as Mike Dougher."

We had what we like to think was a gifted relation to Mike. Every ABAI, when possible, we would arrange to have dinner at some outstanding restaurant in whatever city the conference met, consuming great food and sometimes even greater wines regaled with much laughter at Mike's unique wit. We also have especially fond memories of meeting in New Orleans just to enjoy the peerless food and libations for a few days—special times with his bringing joy to us where it would seem he would live forever—we, and all who knew him have lost a great friend and colleague.

Paul Chance (1941–2021): An Appreciation

Paul Chance, Ph.D., saw the importance of dissemination long ago, and was a stalwart champion intrinsic vs extrinsic motivation debate with Alfie Kohn in of behavior analysis in the popular press. Chance's articles appeared in the New York Times, Psychology Today, American Health, Science 1980, Family Circle, Self, Weight Watchers, APS Observer, and other outlets. His clear and accessible writing on a number of topics helped bring our field to millions. (He was sufficiently in the limelight that he once turned down an opportunity to appear on Oprah Winfrey's program.)

Chance wrote two texts, Learning and Behavior and A First Course in Applied Behavior Analysis, and "L&B" was a widely praised bestseller for many years (first edition in 1979). Chance's other books include The Teacher's Craft, a favorite of one of us writing this remembrance, and Thinking in the Classroom, which was funded by a grant from the National Institute of Education. In 1994, Chance received the SABA Award for Effective Presentation of Behavior Analysis in the Mass Media.

After teaching high school, Chance got his master's degree, then served in the U.S. Navy 1967 to 1969, achieving the rank of Lieutenant. He obtained his PhD in Psychology from Utah State University in 1973. Chance served as an editor and consultant for Psychology Today from 1972 to 1989, but increasingly focused on his freelance career from the mid-1970s on. He taught at the university level for several different institutions. Later, he volunteered

teaching young children computer skills at his public library. He loved teaching, and his highly effective style was reflected in his writing.

One of his high-profile articles was a contribution to the the Phi Delta Kappan (1992 and 1993), a magazine that reached thousands of K-12 educators. Chance's Psychology Today articles covered a wide range of topics; those with a behavior-analytic focus include an interview with Fred Keller and coverage of autism, coma, and head injury. In 1980, his collaboration with Carole Wade resulted in a series of filmstrips on "Basic Concepts in Psychology" that received favorable notice. In 1976, Chance collaborated with Psychology Today colleague Carol Tavris on a Time-Life filmstrip, "The Psychology of Success."

Always appreciative of nature and caring about environmental issues, Chance managed a small private wildlife refuge. Committed to action on the climate crisis, in 2010, he joined Bill Heward in editing a special section of The Behavior Analyst on using behavior analysis to address it. He was as passionate on this subject as he was about our field. He was a beacon for behavior analysis.

"I met Paul when we were young editors at *Psychology Today* magazine in the early 1970s. He immediately became a beloved member of the staff for his dazzling wit, hilarious inter-office memos, and always-candid and well-argued opinions. He was fiercely devoted to behaviorism already, and never wavered in his conviction that behavioral principles would and should withstand the ensuing cognitive revolution in the field. Paul was one of those friends and colleagues who are unique in your life. You're always glad you knew them and you never forget them."

One of the pioneers of Behavior Analysis in Brazil, João Claudio Todorov passed away in his sleep on July 8, 2021, at his home in Brasilia.

I borrowed the title of his article on Fred Keller, published in JEAB (Todorov, 1996), when Keller died. Since I began working at João Claudio lab in 1971, as an undergraduate student, he became forever a respected teacher, a good friend, my "second father," and he is greatly missed.

Born in 1941, in a small town in the interior of São Paulo, the son of immigrant parents, the paths that led Todorov to the analysis of behavior went through a course taught by Carolina Bori when he was still a psychology student. Shortly after (1961), Keller came to Brazil on a sabbatical visit, which resulted in the formation of the first group of behavior analysts in this country. Carolina Bori was Keller's assistant and through her, Todorov met "the Kellers" (the inseparable Fred and "Dona" Frances). The Kellers returned in 1964 for a great "joint adventure" led by Carolina Bori, in the creation of the Psychology course at the recently opened Universidade de Brasília (UnB). Todorov was then a master's student and instructor of the undergraduate course at UnB. Fred Keller encouraged him to pursue a PhD degree at the University of Arizona (Fort Skinner in the desert!), where Keller would work, after Brasília. The subject of his doctoral thesis, supervised by Stanley Pliskoff, emerged from a conversation with a laboratory colleague, Richard Shull, about an article (Shull & Pliskoff, 1967) then in preparation for publication (Todorov, 2021, p.45, Shull, in press).

Back in Brazil (1969), Todorov was hired at the Faculty of Medicine of the University of São Paulo in Ribeirão Preto for four very productive years in terms of teaching and research. Using equipment brought from the United States and housed on loan in the pharmacology laboratory of Dr. Frederico Graeff, Todorov started a research line on avoidance behavior in pigeons that resolved a controversy then under discussion in the area, about the limits of learning. Employing appropriate behavior control techniques, his laboratory demonstrated the feasibility of shaping the key-pecking response to postpone shock (Ferrari, Todorov, & Graeff, 1973), replicated the classic studies of Sidman (1953, 1955) on unsigned avoidance (Todorov, Ferrari, & de Souza, 1973) and on signaled free avoidance (de Moraes & Todorov, 1977), established stimulus control of avoidance behavior under multiple schedules (Gorayeb & Todorov, 1977) and under concurrent schedules of reinforcement (Ferrari & Todorov , 1980). These works involved the scientific training of students at undergraduate (de Souza), master's (Ferrari; Gorayeb) and doctoral (de Moraes; Ferrari) levels.

In 1973 Todorov returned to the University of Brasília, where he retired in 2000, but continued producing and directing research until a few days before his death, in 2021. In the first years of this new phase at UnB, Todorov carried out some other studies on aversive control, but he devoted himself intensively to the study of choice behavior and to the quantification of behavior and the matching law (the list of references is too extensive for this text; most articles are published in *JEAB*). Elenice Hanna and Jorge Mendes de Oliveira-Castro stand out as his main collaborators in this line of research.

In the eighties, inspired by the concept of metacontingency (Glenn, 1986), João Claudio established a line of conceptual analysis and experimental investigations on cultural practices, engaging in a strong national and international research network (Malott, in press; Vasconcellos, Malott, Glenn, Andery, & Tourinho, in press) which included the organization of a series of think tank of cultural studies. With his students, Todorov systematically identified and described contingencies and metacontingencies embedded in laws and public policies (for example, on the rights of children and adolescents, on the conditional cash transfer program in Brazil), or involved in real settings, such traffic, public health, reforestation, incarceration. The abstract of one of his recent articles illustrates the type of contribution and its relevance to science and public policy:

Law 11.340/2006 [Brazil], known as Maria da Penha Law, aims to curb and prevent domestic and family violence against women. This study analyzed contingencies present in the Law focusing on its objectives and the role of the family and society in protecting women. Articles of the law were classified as antecedents, behaviors, and consequences and, subsequently, they were analyzed in order to group the different component terms of the contingencies. The Maria da Penha Law represents advances in relation to its objectives of curbing domestic violence against women and providing assistance and protection to victims. Gaps (incomplete contingencies) related to the role of the family and society in preventing violence have been identified, which can favor multiple interpretations and non-compliance with the Law. Although the law, by itself, does not directly change behavior, the formulation of clear and complete statements, in terms of contingency, is one of the variables to be considered in order to favor its effectiveness. In this sense, the present study adds to previous analyzes of other laws, based on the concepts of contingencies and metacontingencies. The specific analysis of a law to protect women contributes to discussions related to gender inequality, which are still scarce in the context of Behavior Analysis. (Todorov et al., 2021).

This brief summary of a research career, however, is insufficient to speak of João Claudio's enormous influence on behavior analysis, on his students, on the university, and his role in scientific societies and in class organization. He was a man of refined political thought and high sensitivity to social problems. From a very young age he was involved in student organizations and later in teachers' organizations. At Universidade de Brasília he contributed for more than 15 years to the administration, holding the positions of Dean of Research, Vice-Rector and Rector. In these positions, he led the university to participate in important initiatives that culminated in the establishment of public policies. One example was the use of crosswalks in Brasilia, whose legislation created important contingencies that moderated a traffic that had been proving dangerous and even lethal for pedestrians (Sénéchal-Machado & Todorov, 2008).

For his contributions, he received many awards in Brazil and, also, awards from ABAI (Association for Behavior Analysis International) and SABA (Society for the Advancement of Behavior Analysis), such as the status of ABAI Fellow in 2015, the2009 SABA Award for International Dissemination of Behavior Analysis, and the 2020 SABA Award for Distinguished Service to Behavior Analysis.

It is not easy to express in words the influence that João Cláudio had in the field of behavior analysis throughout his long and illustrious career, with his remarkable achievements in research, education and service. His legacy will continue to influence those who lived and learned from him.

In closing, I would like to talk about the human being behind all these accomplishments, as seen and considered by his students and peers. Many people wrote testimonials for a special section that the Brazilian Journal of Behavior Analysis is preparing to honor Todorov, and the amount and diversity of qualifications that people used to refer to João Claudio reflect, at least in part, the positive, affective effects generated in their interactions with him: remarkable human being, unforgettable man/mentor/master, warm- hearted man, remarkable generosity, inspiring, leader, prolific researcher, scholar, rigorous scientist, unwavering fidelity to the principles of Behavior Analysis, a change driver, a promotor (of students, young talents, colleagues, institutions), a barrier breaker, avant-garde, driven by challenges, committed to making the world a better place, a giant in the field of behavior analysis, dedicated to creating opportunities for others, highly productive, energetic and enthusiastic, with a special ability to hear and respect different voices, open and friendly with students and colleagues ...

ABA Germany

ABA-D is devoted to representing and communicating ABA to the German public as a socially and ethically viable and scientifically based therapeutic intervention in various settings.

This past year, we have been undertaking strong efforts to establish contact and to network with organizations, who are devising standards and recommendations about autism treatment within Germany. ABA-D has created, in partnership with physicians and other stakeholders in the field of autism, a set of ABA Quality Criteria to be submitted to the German Ministry of Health in order for ABA to be approved as a therapeutic intervention for individuals diagnosed with autism spectrum disorder.

We have also begun the process of working together with the Professional Association of German Psychologists (Berufsverband Deutscher Psychologinnen und Psychologen) to establish the BACB professional qualifications as comparable with those of Licensed Psychologists.

ABA-D has been preparing and collaborating with other stakeholders to establish the framework for a postgraduate course sequence in the field of ABA.

We have grown to include 48 members. The 2020 annual meeting was held online as we were all faced with a worldwide pandemic. However, we look forward to our next in-person meeting in Berlin.

ABA Lebanon

The Alberta Association for Behaviour Analysis (AltaABA) is in its fifth year as an affiliated chapter of ABAI. In March 2020, AltaABA held online elections for their student member position. All other open positions were uncontested. The Annual General Meeting (AGM) for members occurs in the Spring of each year and, unfortunately, 2020's AGM was cancelled when we were all faced with the COVID-19 pandemic. The AltaABA membership was sent a digital AGM report to provide the required updates on committees, finances and future activities.

The 2021 AGM was held virtually in May and was paired with an invited speaker event discussing literacy development using Direct Instruction by Michael Maloney. In May 2021, AltaABA also welcomed new members to its Board of Directors, following nominations in March 2021 and online voting by the membership in April 2021. Australian Association for Cognitive Behaviour Therapy

The President of Australian Association for Cognitive Behaviour Therapy (AACBT) is Associate Professor Melissa Norberg, deputy director of the Centre for Emotional Health, and director of the Behavioural Science Laboratory at Macquarie University.

2020 was a difficult year for our members and our organisation, and we continued to pursue our vision of improving the quality of practice of behavioural and cognitive therapies in Australasia, by providing high quality professional development in behavioural and cognitive therapies based on scientific evaluation.

We hosted a mixture of local and international presenters, with a dozen recordings being made available for free to members, representing nearly 20 hours of highquality content, plus associated readings, and materials. Examples of some of the topics covered include mental imagery, OCD, trauma & race, digital CBT, CBT apps, suicidality, social anxiety, grief, and loneliness.

The on-line format for presenting CPD allowed us to embrace a wider diversity of speakers, with several domestic speakers gaining national exposure, rather than only in their home state. We were also pleased to be able to present long-form workshops from international speakers such as Roz Shafran, Martin Antony, David M. Clark, and Emily Holmes.

We are committed to maintaining an on-line presence in 2021 and look forward to expanding our catalogue of recordings for members, plus investigating what our 41st National Conference might look like. The National Board thanks our Branch Chairs, and the National Workshops & National Conference Coordinators for their on-going efforts.

In 2020, AACBT expanded our National Award program with a mid-career award being added to the portfolio of awards, joining our early career and distinguished career awards. The 2020 award winners were: Dr. Erin Kelly (early career), Dr. Michelle Moulds (mid-career), and Professor Peter Norton (distinguished career). Each winner recorded their presentation, highlighting their scientific output and contemporary research, and the recordings are available as additional presentations in our catalogue. Our 41st conference took place in 2021, and AACBT continued to offer Early–Mid Career Travel Grants to members to support travel (where possible) to the AACBT National Conference following acceptance of either an oral or poster presentation. These grants provided complimentary scientific program registration, plus up to \$1,000 to help cover eligible travel expenses for the applicant to attend the conference. This on-going initiative invests in the CBT community of Australia and encourages on-going research into CBT. The Board thanks our National Conference Coordinator for their service in supervising our largest annual event.

Improvements to our web portal are continuing, with the recent addition of a members only e-library, and a new subscription option for members. Members have access to exclusive areas of the website, which includes access to our annual reports, our journal ("Behaviour Change"), webinar recordings, and the growing e-library (with over 40 titles).

The Board recognises and acknowledges the work of our most recent past editor (Professor Ross Menzies) of our journal *Behaviour Change*. Professor Menzies has retired after many years of service, and we welcome our new editor (Associate Professor Genevieve Dingle) and her editorial board, who will be overseeing growth and improvements for our journal.

Behavior Analysis Association of Michigan

We are pleased to once again report the success of behavior analysis in Michigan, and the many positive contributions of our members to the effective, ethical, and science-based treatment of problems associated with autism, traumatic brain injury, addiction, and other conditions—but also not forgetting the important work of those in Organizational Behavior Management, behavioral medicine, education, behavioral research, university and college instruction, animal training, and other areas. Licensure of Behavior Analysts in Michigan is official and has, by all reports, been running smoothly, with hundreds of new Licensed Behavior Analysts in the State.

The Annual convention of the Behavior Analysis Association of Michigan (BAAM) was a great success. It was held February 20-21, 2020, at the Student Center on the campus of Eastern Michigan University (EMU). We had over 700 attendees, down about 50 from the previous year, making the conference attendance better fit the venue. The 700-plus attendees came from more than a two dozen universities and colleges, over a dozen states, and two Canadian provinces. The continuing high attendance figure, along with that of the Michigan Autism Conference, offered by our friends at Western Michigan University, speaks to the Desensitization: A Missing Piece to Treating Pediatric tremendous success of behavior analysis in Michigan.

BAAM attempted to streamline the number and type of sessions to fit the conference more effectively into our venue, which is also under new management. Sessions were booked in the largest rooms available, and we were successful in accommodating our attendees in the sessions they wanted to see. We are especially grateful to the students at Western Michigan University for their many fine poster presentations and enthusiastic participation in our largest-ever poster session.

Many local and regional agencies sent staff and administrators, reflecting the expansion of behavior analysis opportunities in the state. The growing participation of faculty and students from Central Michigan University, Michigan State University, and Oakland University, and University of Toledo did not go unnoticed. We were pleased to be able offer some space in our schedule and poster session to our friends in related areas of clinical and applied intervention. BAAM scheduled all regular sessions in meeting rooms overlooking EMU's Lake House area. The support of the Eastern Michigan University Psychology Department, BAAM's sponsor, was again essential to our success. BAAM once again had two Keynote addresses. The Thursday Keynote, "Young Skinner on Stimulus and Response Classes," was delivered by David Palmer of Smith College. Palmer's well-received presentation gave us the history of the develop of the concepts of stimulus and response classes, as revealed in B.F. Skinner's early writings. The Friday Keynote, "The War on Science: The Invasion of ABA?," by Kimberly A. Schreck of Pennsylvania State Harrisburg, described how the recent attacks on basic and applied science have affected behavior analysis, and led many, including some behavior analysts, to embrace and

endorse pseudoscientific ideas and interventions.

The many other convention sessions are too numerous to fully list. Here is just a sampling: "An Important Chapter in the Story of Behaviorism," by Jay Moore (University of Wisconsin-Milwaukee); "Enhancing the Seven Dimensions of Applied Behavior Analysis With Dieter Rams's Ten Principles of Design," by James T. Todd (Eastern Michigan University); " The ACT Hexaflex through the Lens of Traditional Behavior Analysis," by Scott T. Gaynor (Western Michigan University); "Oral Feeding Disorders?" by Natalie K. Morris (University of Michigan Medical Center), "Recent Research on Social and Play Skills in Children with Autism," chaired by Emma S. Sipila-Thomas (Michigan State University); "Effects of Schedule Modifications on Toilet Training Children with Disabilities," by Nicole Hollins, Rebecca L. Kolb, and Stephanie M. Peterson (Western Michigan University).

The writing was on the wall for BAAM's 2021 conference, which was cancelled early due to COVID restrictions. For the protection of everyone involved, BAAM began planning on a limited set of online offerings to be held at about the same time as the annual conference in 2021. If restrictions are lifted, BAAM will hold an in-person (or in-person/online hybrid convention) on February 24-25, 2022 in the Student Center on the Eastern Michigan University campus. The 2022 conference dates are tentative. We anticipate some limitations in capacity, even if an in-person conference is possible. Behaviour Analysis in Ireland

The following are a list of activities of the Chapter over the past 12 months, including information about upcoming events and membership details.

Conference Review: The 14th Annual DBA Conference

The Fourteenth Annual conference of the Division of Behavior Analysis (DBA), Psychological Society of Ireland for 2020 was held virtually this year. In spite of the changes, and the virtual environment the conference was a great success. It took place over two days, 21-22 August, 2020. The conference was very well attended, with both national and international delegates and speakers joining.

The first day of the conference involved three workshops, each two hours long. The workshops were: The Importance of Parental Training when Working with Children Diagnosed with ASD given by Dr.

Stephen Gallagher (Ulster University, Northern Ireland), Ethical Considerations for Practitioners Working with Non-Behavioral Professionals given by Dr. Berglind Sveinbjörnsdóttir (Reykjavik University, Iceland) and Up-dating RFT and Implications for Applied Behavior Analysis given by Prof. Dermot Barnes-Holmes, Dr. Carol Murphy, Dr. Michelle Kelly and Dr. Colin Harte.

The second day consisted of two panel discussions and two keynote addresses. The panel discussions were on the following topics: The Human Rights Agenda: Understanding the Current Context and Responding to the Challenges and New Developments in Functional Assessment. Panels were hosted by experienced Irish clinicians and involved discussion points, questions and answers and engagement from attendees. The two keynote addresses were: "Problem Behavior in Transitions Between Activities: Implications from Basic, Translational and Applied Research" by Dr. Berglind Sveinbjörnsdóttir (Reykjavik University, Iceland) and "Six Metaphysical Sources of Reinforcement" by Professor Pat Friman (Boys Town & University of Nebraska School of Medicine, USA).

The conference also hosted a number of poster presentations, which were submitted by delegates in PDF format and made available to conference attendees through an online folder. Two prizes were awarded for best poster presentations.

General Meetings and Other Activities

In February 2020, the Division held an Extraordinary General Meeting for members and all those with a vested interest in behavior analysis in Ireland. The topic of the meeting was to discuss recent international developments regarding the certification of behavior analysts. The meeting was very well attended with high levels of interest and engagement. In November 2020 the Annual General Meeting of the Division took place to elect members of the committee and provide updates to members. The AGM was held online and was well attended.

The Division has been actively involved in a number of processes aimed at regulating behavior analysis in Ireland. This has included providing feedback to national regulatory bodies and supporting the development of an additional group to represent behavior analysts in Ireland.

Upcoming Events

The Division has decided to not host an annual conference in 2021, but instead held a number of workshops over the course of the year. The Division is aiming to host an in person conference in the first half of 2022.

DBA Membership

The Psychological Society of Ireland (PSI) is the body representing professional psychologists in Ireland. The DBA represents recognised qualified professionals in the science of behavior analysis. Those wishing to apply for membership must be members of PSI and hold a postgraduate qualification in behavior analysis recognised by the Division Committee. Berkshire Association for Behavior Analysis and Therapy

BABAT is Massachusetts' largest and longest-standing professional organization for behavior analysts. We celebrated our 41st anniversary in 2020. The year 2020 was a busy and tough year for CABA. On the 17th of February 2020, together with The Professional Committee of Autism CARDP, we organized settings that included human behavior. a national wide free online resource for families whose children are affected by the outburst of COVID-19.

sectionm, information on how family members could help their children with needs to understand and practices safety prevention requirements. a "What Is Autism" section, information on what should be done during this critical period to prevent problem behaviors, and information on how ABA principles should be implemented in the home setting by parents.

On the March 20, 2021, we held our sixth annual individuals from all around the country attended. This year's conference with support from the China Association of Rehabilitation of Disabled Persons, Peking University Sixth Hospital. French ABA

The Iowa Association for Behavior Analysis annual members' meeting was October 9, 2020. Due to COVID-19, it was held virtually and was held in conjunction with the eighth annual conference. There were a number of newly elected board members. In 2020, Iowa ABA offered 19 CEU's to members through conference and workshop opportunities. In the summer of 2020, a 4-hour ethics workshop was held for members. Dr. Matthew Brodhead, Michigan State University, presented "A Behavioral Systems Approach to Ethics Training and Supervision". Iowa ABA continued to extend on the Annual Conference to include a Post-Conference Workshop. Conference presenters provided training and presentations on varied topics to 46 workshop attendees and 80 conference attendees. The Annual Conference included four speakers including Dr. Sarah Mead Jasperse, Emirates College for Advanced Education in Abu Dhabi, United Arab Emirates, presented "Treatment 'Failures' in ABA: What They Are and How

Officers, LLC, presented "How We Know THEY Know: Rehfeldt, Chicago School of Professional Psychology, presented "Creating Compassionate Cultures: Acceptance and Commitment Training in Human Service Settings"; Dr. Becca Tagg, Del Mar Center for Behavioral Health, presented, ""Providing for the Provider: Burnout, Self-Care, and Community Care". Shannon Biagi, Chief Motivating Officers, LLC, presented the workshop, which was on "Planning for Growth: Creating Professional Development Pipelines in ABA." Monetary support for the conference was provided by local, state, and regional organizations with an interest in behavior analysis.

The ninth annual conference was held virtually again on October 1, 2021. A post-conference workshop was held in

The board conducts open meetings on the second Thursday of each quarter (with the exception of the final quarter during which the meeting is held at the annual conference) and invites members to participate in meetings and on committees.

BCBA licensure remains in effect in Iowa after the application for licensure became active on March 15, 2019. The Legislative Action Committee continues to advocate for and protect Iowa licensure and currently occupies two seats on the Iowa Board of Behavioral Science by individuals with interest in behavior analysis, a BCBA and a BCaBA. A third seat still needs to be identified. The legislative committee has been involved with a variety of initiatives that impact BCBAs in the state, such as Medicaid supporting and reimbursing for ABA services via telehealth and BCBA's being recognized by the Board of Education in Iowa.

Iowa currently has 149 BCBA/BCBA-Ds, 2 BCaBAs, and 135 RBT's. Iowa ABA has supported several initiatives to recruit and retain BCBAs. Currently Iowa ABA has 125 members with 75 full, 16 affiliate, and 34 student members. The expansion of ABA services and BCBAs in Iowa continues to be of utmost importance to Iowa ABA. For this reason, Iowa ABA has continued to support a state grant for individuals pursuing their certification and has also shown support for Drake University's ABA master's program, with members providing practicum opportunities for students, supervising clinical experiences, and promoting the program. Iowa has financial incentives for those new certificants who are employed in Iowa with a state funded grant program.

Israel ABA

The Israeli Applied Behavior Analysis (IABA) affiliated chapter—2020 A year to remember

2020 will be a year to remember, not only because of the COVID-19 pandemic that impacted many aspects of our personal and professional lives, with IABA's activities being no exemption, but also because of a wind of change in the field of behavior analysis in Israel. Alongside routine activities to disseminate the field of behavior analysis in Israel that included annual conferences, workshops, and other initiatives, IABA—in collaboration with the "Mentha" organization (an organization of the Israeli board-certified behavior analysts)—launched an initiative to promote Israeli licensure and certification. The activity of the designated licensure and certification committee was most notable in 2020 and is the focus of this report.

Following the BACB's announcement concerning the limiting of certification to behavior analysts who practice in the United States and Canada, IABA-in cooperation with Mentha organization-established a new Regulation Committee with the aim of achieving official recognition of the field of behavior analysis in Israel under the health professions law. With this important goal in mind, 15 members who lead the field in Israel in different sectors, including public, private and academia were drafted. These members were assigned to various subcommittees with the expectation to set high professional standards for the practice of behavior analysis in Israel and to create initial guidelines needed for the regulation of the field. Seven subcommittees were formed that include the following: task list, practicum, certification exam content, exam administration, ethics, continuing education and a support committee. Each subcommittee had five members and held several meetings. Progress reports were provided at regular monthly committee meetings. The work of these committees concluded in 2021, with the goal to administer the first Israeli certification exam by 2024.

In February 2020, IABA held its annual conference titled "Environment that Creates Reality." The conference included lectures by leading behavior analysts allied with experts in different fields such fitness and nutrition and received very positive reviews by the participants. Other activities of IABA included recruitment of new members and active use of social media communicating progress with regulation and various updates relating to the field.

Finally, due to the COVID-19 pandemic, IABA held fewer activities in 2020 than planned. Accordingly, IABA decided to offer free membership renewal in 2021 for behavior analysts who were members in 2020. IABA increased its number of members in 2020 to about 400 members. Besides pursuing the organization's regular committee activities, IABA's goal is to vigorously continue promoting regulation of the profession in Israel and to advance the merger with the Mentha organization to the benefit of the behavior analysis community in Israel.

Japanese ABA

The last step in obtaining the certification requires candidates to attend a half day workshop and pass an exam covering the rules and regulations regarding behavior analytic practice in Ohio. The Board has committed to having representation at each of these workshops to assist in answering questions and to ensure newly certified members are aware of OHABA as a resource.

Future Direction

Philippines ABA

In the first quarter of 2020, the Philippine Government declared the whole country under "General Community Quarantine" due to the COVID-19 outbreak which limited all sectors to be confined in their respective areas unless work is considered "essential." Due to the nonlifting of the quarantine status throughout the year in the country, unfortunately, Philippines ABA (PABA) was not able to fulfill its scheduled activities for fellowship and training for the year as all mass gatherings were prohibited. Majority of local ABA practitioners suffered greatly the consequence of the quarantine and had to put their ABA practice and services on hold due to the uncertainties caused by the COVID-19 pandemic to the country's economy and health care condition.

PABA members practicing ABA were faced with numerous challenges in continuing their practice and offer their services. Their concerns were brought to the attention of PABA to provide assistance. By the third quarter of the year, it was essential for PABA to address the urgent needs of its members and affiliates seeking assistance in promoting and setting ABA services through an online or virtual services for their practice and clients. PABA through some of its members who were successfully able to set up their own teams for a virtual program, put up a help desk for its members giving guidance in preparing ABA practitioners to move their practice and offer their services virtually. PABA had to focus in assisting members need. Likewise, PABA extended assistance to medical practitioners in preparing their clients to adjust to a virtual learning set up. The initial goal of these universities is to integrate ABA classes into their roster of degree courses based on the Philippine education set up and eventually fulfilling a full ABA degree course.

The unfulfilled PABA projects for 2020 were added to future projects should the Philippine Government lift all quarantine restrictions.

In 2020, the pandemic generated by COVID-19 did not affect the publication of the *MJBA*. In fact, the journal started the year with a new editor (Carlos Flores) and the publication of a special section on the 70th anniversary of the appearance of *Principles of Psychology* by Keller and Schoenfeld (visit http://rmac-mx.org/).

Unfortunately, this year's Mexican Conference on Behavior Analysis did have to be postponed due to the pandemic generated by COVID-19. However. MSBA held this conference virtually in 2021. The event was part of the celebrations for the 30th anniversary of the founding of University of Guadalajara's Center for Studies and Research in Behavior; the first research institute of its kind in Latin America and, it should be noted, based on a strictly behavioral point of view about psychology. The Center was founded by Emilio Ribes Iñesta, also founder of our Society and, most likely, México's most important academic psychologist in the area of behavior analysis.

2012 also included keynote addresses held by important Ethics Committee figures of Mexican psychology such as Emilio Ribes, Carlos Bruner, and Kennon Lattal.

The MSBA hopes the pandemic generated by COVID-19 comes to an end as soon as possible and that its effects on academia and the world in general have the least possible impact.

South Carolina ABA

A focus on celebrating community became our theme during the pandemic. Information and educational opportunities were made available to SC ABA membership regarding licensure, including a licensure discussion and update featuring Gina Green on March 13, 2020, frequently asked questions and informational postings on our website, a conference presentation hosted by our lobbyist and house representative sponsor, and a series of Q&A town hall events. The chair of the committee is David Green. Committee members include Kerri Krauss, Zahra Haji, Scott Braud, and Anna Craft.

Social Committee

In 2020, SC ABA had to adjust their original plans of hosting regional social networking and community services events due to the pandemic. Two online socials were hosted • instead featuring opportunities for members to play trivia, share experiences, and collaborate. The Social Committee Chair was Kimberly Snyder.

In March 2020, in response to the pandemic, SC ABA sponsored a free webinar entitled "Ethical Service Delivery Models in the Time of COVID-19: A Risk-Benefit Analysis Tool" and offered free CEUs to attendees. Southeastern ABA

The Southeastern Association for Behavior Analysis (SEABA) is a regional affiliate of the Association for Behavior Analysis International (ABAI). Like its parent organization, SEABA seeks to promote scholarly discourse within and about behavior analysis. SEABA membership is open to anyone with a scholarly interest in Behavior Analysis who registers for our annual meeting. Current members include established scholars, professionals, and students in psychology as well as related disciplines such as education, psychopharmacology, and social work. Most members reside in the southeast, although some members participate from other parts of the United States.

History

In 1984, Aaron Brownstein (University of Noth Carolina, Greensboro) rallied a group of prominent behavior analysts in the Southeastern U.S. around the idea of a regional conference on the science and philosophy of behavior analysis. The Southeastern U.S. contained a large number of strong but geographically scattered academic and research groups (e.g., Florida, North Carolina, West Virginia, Alabama, and others) and without a venue for scholarly interaction. For many, the Southeastern Psychological Association had served this purpose, but the content of that conference had become overwhelmingly professional rather than scientific (i.e., following the direction of APA). SEABA was founded to be that venue for behavior analysts. SEABA was structured specifically to foster high-level discourse on research and theory in behavior analysis. The organization's sole activity would be to conduct an annual conference. The conference format was developed specifically Inclusion Committee co-chaired by Dr. Aaron Fischer to replicate the environment of early behavioral conferences, and scientific specialty organizations (e.g., the Behavioral Pharmacological Society). To this end, the conference was to be a day and a half, single-track program so that all participants could conveniently attend all presentations

establishing a common basis for discussion and interaction. Speakers were to be selected based on content and quality of their empirical and theoretical work, and to comprise a well-balanced program of basic, applied, conceptual and philosophical presentations. The fall was selected to complement the main ABAI convention held in the spring, and the first meeting was held in the fall of 1984 in Myrtle Beach, South Carolina.

A Special Emphasis on the Future of Behavior Analysis

A guiding philosophy of SEABA is that students are junior colleagues, with an emphasis on the latter portion of the term. Consequently, SEABA strives to keep membership and convention registration fees low to facilitate student attendance. By SEABA tradition, students typically assist in the planning and orchestration of the annual meeting, introduce the invited speakers, and contribute to its scholarly well-being through numerous poster presentations.

Mission for Behavior Analysis

SEABA serves the development of behavior analysis by advancing and reinforcing its scientific underpinnings. A SEABA member who served as student introducer, speaker, and president summarized SEABA's role in the development of behavior analysis as follows:

"SEABA has never sought to influence behavior analysis directly, but its influence is wide nevertheless. A disproportionate number of JEAB and JABA editors and editorial board members in recent years are SEABA members and alumni. One could argue that the nurturing of students in the science and philosophy of behavior analysis is the organization's greatest accomplishment."

Virginia ABA

The Virginia Association for Behavior Analysis (VABA) is the affiliate chapter of ABAI in Virginia. We represent behavior analysts in Virginia and ended 2020 with over 600 members! Unfortunately, most likely due to the COVID-19 pandemic, our membership decreased by 26%. The Commonwealth of Virginia has the ninth largest certified BCBA-Ds, BCBAs, BCaBAs, and RBTs (combined) in the United States. The association has been in existence since 2003 and is a 501(c)(6) organization. VABA contracts with a lobbyist and has one paid position, an administrative director.

Based on member survey data, we decided to continue the strategic components of our goals:

- Goal 1: Improve viability and sustainability of the organization.
- Goal 2 Provide quality service to our members.
- Goal 3 Advocate for the science of behavior analysis in the Commonwealth.

We are frequently monitoring our strategic plan to find better ways of serving our members.

In 2021, we held a hybrid conference in Newport News in April and online via Whova. We formed a Diversity, Equity, and Inclusion Committee that has had a great response and started a Dissemination Committee that continually works to disseminate the science of behavior analysis around the Commonwealth. We built a supervision search engine to help supervisees and others find mentors and vice-versa. Finally, we are started special interest groups based on location to serve our members' needs better.

With our lobbyist's help, we introduced a budget amendment to conduct a rate study to move to our Category 1 CPT codes for Medicaid billing. Currently, we use the Multi-Systemic Therapy code to bill, and the rates are not tiered. We have an active Policy Committee and are continually looking for areas to facilitate and disseminate behavior analysis in Virginia.

In 2020, VABA distributed four newsletters that were each opened by half of our membership or more. We published four blog posts with information that affects practitioners in Virginia, including public comment recommendations. We communicated to over 1,600 people via Facebook, over 1,400 via Twitter, and over 200 people on our newer Instagram account. We publicized more than 30 jobs on our website. We made a quick shift to a virtual conference in April 2020 and had over 200 attendees and seven sponsors. The COVID-19 pandemic curtailed our in-person continuing education events and networking happy hours, but we held six Webinars and a three-part Student Symposium. We published an annual report on our website: www.virginiaaba.org/about/annual-reports/.

VABA Membership offers many benefits, including an annual conference, networking opportunities, quarterly newsletter, CEU offerings (including the conference and beyond), members-only resources including supervision resources and a search engine, lobbying and policy efforts, and discounts on a variety of outside products. 
West Virginia BAA

Updates From ABAI's Special Interest Groups

Acceptance and Commitment Training

Over the past few years, a number of behavior analysts have become interested in psychological flexibility, or behavioral flexibility, as an important dimension of human behavior. As a result, an increasing number of practicing behavior analysts have sought to integrate Acceptance and Commitment Training, which directly targets behavioral flexibility, into the applied behavior analysis services they provide.

Consistent with the behaviorally based psychotherapy approach, Acceptance and Commitment Therapy (Hayes, Strosahl, & Wilson, 1999; 2012), Acceptance and Commitment Training (ACT) aims to increase behavioral flexibility, or sensitivity of the behavioral repertoire to changing contexts in such a way as to foster valuesconsistent, goal-directed responding. In this way, ACT offers behavioral flexibility as a fundamental aspect of human health and well-being (see Kashdan & Rottenberg, 2010), contrasted with the inflexibility that characterizes repertoires academicians, researchers, and practitioners from a variety dominated by rule-governed aversive control (Levin, Hayes, & Vilardaga, 2012). As applied behavior analysis grows in popularity and expands into new settings and domains, behavior analysts are increasingly confronted with behavioral repertoires dominated by persistent avoidance, excessive rule governance, and subsequent difficulty building effective, personally meaningful repertoires. ACT offers a theoretically consistent, empirically based approach to directly addressing this challenge by incorporating flexibility into assessment and intervention.

The Acceptance and Commitment Training SIG was approved to affiliate with ABAI in 2018 with the mission to bring together professionals who have an interest in exploring and disseminating the application of Acceptance and Commitment Training (ACT) within the training and delivery of applied behavior analytic services. The ACT SIG held its first election, and is pleased to announce new board members, the first elected by the membership:

With the goals of creating a sustainable leadership structure and clarifying primary activities of the SIG consistent with the mission, the board has continued efforts to advance the

mission and objectives of the SIG. The board participated in the 2020 ABAI conference online by disseminating information about the SIG at the Expo, attending the Leadership Training, and organizing and executing the first SIG Business Meeting. In 2020, the ACT SIG also established dues (\$15) and transferred membership services to ABAI. and growth for the SIG and our profession as a whole. Ultimately resulting in improved intervention for autistics/ BY ABIGAIL CALKIN individuals diagnosed with autism.

Behavior Analysis in Military and Veterans' Issues

The Military and Veterans (MilVet) SIG is entering its tenth year of operation at ABAI. The SIG focuses on how the field of applied behavior analysis (ABA) can contribute to those who currently serve or previously served in the military. There are many issues that concern the military and veteran communities (e.g., suicide, PTSD, TBI, and autism). Co-chairs, Abigail Calkin and Kent Corso, and members remain excited about working on the issues and needs of this specific population. During its early years, the SIG devoted a significant amount of time to increasing membership, while also examining viable ways of accessing the military and veteran community. A few exciting projects are now well underway that have helped recruit additional members.

The MilVet SIG currently has 105 members. When the co-chairs first applied to be a SIG there were 14 members. One of the MilVet SIG members, Megan Miller, created a Facebook page on May 28, 2014: Behavior Analysis in Military and Veterans' Issues SIG. The site is a closed group, which grew to 86 members in its first year. At the end of its second year, it had 190 members, an increase of 220%. In its third year, membership was 252, and as of February 28, 2021, the page had 612 members.

This year, SIG members are wrapping up a three-year long research project at Whiteman Air Force Base, the Air Force installation with the most suicides among all Air Force installations. SIG co-chair, Kent Corso, leads the team, including SIG members Jim Meador, Abigail Calkin, and Mike Kondis. Currently, archived data is being collected, mirroring the pilot study these same SIG members conducted in 2016-17 for the Air National Guard. Additionally, this team will release the expanded version of the only native application for the standard celeration chart (i.e., AimStar Pro), making the digital standard celeration chart accessible on iOS devices world-wide! In January 2020, the same team launched the first API for the digital standard celeration chart, for the first time in history, enabling computers to communicate about data and automatically generate a standard celeration chart for those data. This team also published a research paper in the journal *Families, Systems & Health*, using the API to analyze COVID-19 data. The article was published here in March 2021: www.apa.org/pubs/journals/fsh.

Our Facebook page contains weekly questions and requests about opportunities to learn more about how to treat this population and where to gain such experience. The absence of formal systems of ABA care delivery within the Department of Defense and Department of Veterans Affairs continues to be a barrier to providing ABA providers access to helping this population. SIG member Dr. John Borgen, now at Mississippi State University, has completed his literature review to help support advocacy for ABA's application in the Departments of Defense and Veteran Affairs medical systems. The SIG formally requested that ABAI partner with it to discuss potential advocacy and collaboration to address this issue. The critical barrier for spreading ABA to veterans and service members is that it does not meet the requirements contained in federal regulation: 32 CFR 199.2 definition for reliable evidence standards. Without inclusion in this federal statute, ABA will not be accepted or reimbursed for anything other than autism within these medical systems.

There is much that the field of ABA can contribute to the military and veteran community. Despite the barriers, the SIG will continue to support this community, raise awareness and build momentum through the ABA community at ABAI and elsewhere. Professional conferences are great opportunities to meet prospective members of the MilVet SIG, current members, and the cochairs. Clinical

ABAI's Clinical Special Interest Group (SIG) was originally organized in 1979. Active membership has been consistently maintained since. The Clinical Special Interest Group continues to serve as home to those who have an interest in the clinical application of behavior analysis. Clinical Behavior Analysis (CBA) was once defined as the application of radical behaviorism (Skinner 1953, 1974) to answer the most basic questions about outpatient adult behavior therapy (or any other type of psychotherapy) (Kohlenberg, Tsai, & Dougher, 1993). This application of behavioral theory has continued to expand to other areas of clinical services through the years. Clinical behavior analysts now contribute to research and treatment of mainstream clinical populations and problems, working in a variety of research and applied settings.

At the current time the Clinical Special Interest Group does not require dues. We do accept donations for student-focused support initiatives. For the 2020–21 SIG year, we have a membership of 175 members. While we are excited to have this number in our membership, we continue to be interested in growing in both clinician, research, and student membership.

The Clinical Special Interest Group produces an annual newsletter directed to highlighting members' contributions to the ABAI convention and other areas of behavior analysis.

At the 2021 convention, the Clinical Special Interest Group presented information related to the SIG at the ABAI Expo and met for an annual business meeting to work towards the expansion of SIG led projects.

We are also striving to collect information from Clinical Behavior Analysis academic training programs and research labs so that we can promote workshops, conference events, and ongoing activities of interest to our membership.

The Clinical Special Interest Group is also working to develop opportunities to recognize and support students and researchers focused on clinical interventions.

Finally, we maintain a listing of university-affiliated training opportunities in the area of Clinical Behavior Analysis that is openly available upon request or membership.

Crime, Delinquency, and Forensic Behavior Analysis

The mission of the Special Interest Group (SIG) of the Association for Behavior Analysis International (ABAI; www.abainternational.org/aba.asp) is to ensure that those in the criminal justice fields have access to appropriate, evidence-based behavior analytic therapy to reduce crime and delinquency. Behavioral interventions can reduce prison misconduct (French & Gendreau, 2006). SIG members have testified on behavioral intervention to reduce crime. Behavioral interventions can reduce crime by approximately 13-20% (Redondo-Illescas, Sánchez-Meca,&Garrido-Genovés, 2001) and prison misconduct (French & Gendreau, 2006).

The SIG plans to remain active in this area over the coming year. Behavioral parent training is a well-established treatment for oppositional defiant disorder and conduct disorder, which are often forerunners to adolescent delinquency (see O'Donohue &Ferguson, 2006).

Finally, behaviorally-oriented residential treatment programs are listed by the Surgeon General as promising for children and adolescents with conduct disorders. Recent evaluations of the literature suggest that the program is even more effective on post-release recidivism than first thought (Kingsley, 2006) so the results are promising.

Dissemination of Behavior Analysis

The Dissemination of Behavior Analysis Special Interest Group (DBA-SIG) held our annual meeting and social event at the 47th Annual Convention of the Association for Behavior Analysis International (ABAI) online. All attendees were invited to express their thoughts and suggestions in an open and inclusive discussion of our progress and future endeavors. In addition, officers met on a monthly basis and provided regular updates to our members through newsletters, town hall meetings, and social media. We provided 12 free monthly continuing education events to members that included a broad range of topics such as police academy training, autism and law enforcement, mixed martial arts and other sports, animal training, and international efforts. Our continued mission is to disseminate the science of human behavior to the public at large, through easily understood explanations. Our goal is to promote behavior analysis in a positive and accurate light, to help society realize the potential of our science.

The DBA SIG Grant contributed significantly to the creation and publication of one of the only open educational resource textbooks in behavior analysis. The volume is titled Special Topics in Behavior Analysis and includes 15 chapters, each discussing an area of application of the science of behavior. Authors include doctoral and master's level clinicians from across the Midwest-each presenting their area of expertise as it relates to behavior analytic philosophy, practice, and future directions for additional research. The text became available during Summer 2021 through Pressbooks as a freely downloadable ebook and may be purchased for a small fee from the publisher. Individuals interested in accessing a copy may contact the editor at MPavone@Lindenwood.edu. The text is part of the Lindenwood University Verified Course Sequence in Behavior Analysis and is promoted on the VCS coordinator's listserv to increase adoption in other graduate-level behavior analytic training programs. In addition, the text is licensed under the CCBY creative commons designation meaning that users may reuse, retain, revise, remix, and redistribute the resource; a wonderful way to break down barriers to dissemination, reach new audiences, and continue to allow experts to improve and expand the text over time.

As we look to the future, the DBA-SIG is excited to report the results and impact of all grant winning projects. We encourage all behavior analysts to engage in value-driven efforts to disseminate our science to new and emerging areas with a focus on personal, social, and cultural inclusion with acceptance. We envision a world in which behavioral science permeates the fabric of society and moves us toward a thorough understanding of behavior. We are committed to this end and to assisting others in their pursuit of this goal. Students (\$15) and professionals (\$20) who wish to join and participate in the DBA-SIG, can become members through our website (www.dbasig. com). Benefits include eligibility for dissemination grants, free monthly BACB ACE Provider events, and access to a vibrant community of advocates and resources.

Naturalistic Developmental Behavioral Intervention

The NDBI SIG was founded in May 2020 by Sophia D'Agostino (president), Melanie Pellecchia (member-atlarge), Elizabeth Horton (secretary-treasurer), Emma Sipila-Thomas (student member/secretary-treasurer), Ana Dueñas (member-at-large), Amy Matthews (member-at-large), and Meghan Kane (member-at-large). The NDBI SIG aims to bring together professionals who have an interest in understanding and advancing the dissemination and implementation of naturalistic developmental behavioral interventions for individuals with autism spectrum and related disorders. The NDBI SIG has three primary purposes: (1) Advance the understanding of NDBI among

behavior analysts; (2) disseminate the latest research and practice related to NDBI in the treatment of individuals with autism; and (3) provide a forum for behavior analysts interested in NDBI to network and collaborate.

NDBIs are empirically validated interventions implemented in natural settings using components from developmental and behavioral science. A recent metaanalysis recognized NDBI as a promising intervention approach for children with autism (Sandbank et al., 2020). Common examples of NDBI approaches include incidental teaching, pivotal response treatment, Early Start Denver Model, enhanced milieu training, and many more. In order to bring parsimony to the field, Schreibman et al. (2015) proposed the common use of the term NDBI to refer to interventions that combine ABA with developmental science. The core elements of NDBIs as identified by Frost et al. (2020) include (1) face-to-face on the child's level, (2) follow child's lead, (3) use positive affect and animation, (4) model appropriate language (5) respond to communicative attempts, (6) use communicative temptations, (7) provide frequent direct teaching episodes, and (8) provide quality direct teaching episodes. Please see our website for a list of recent NDBI publications and other resources including videos and books to learn more about NDBI.

Practitioner Issues in Behavior Analysis

The BACB's model licensing act also drew heavily from the PIBA SIG's model act to meet the needs and concerns of BCBA and BCaBA practitioners. This SIG provides a means of discussion, support and potential for action per member input and decision among ABAI members. The SIG collaborates with other SIGs and boards of ABAI or external organizations as individual members on legal and ethical issues pertaining to the practice of behavior analysis. We promote and support means of ensuring the continued ability for behavior analysts to practice as independent practitioners. The SIG provides a means of communicating about current trends and concerns pertaining to the practice of behavior analysis, licensing matters, legislation issues, insurance regulations and billing practices and updates, and efforts to place barriers for such practice by outside organizations or individuals. We help support and promote the ability for behavior analysts to be on insurance panels to provide services to family members with autism and other areas of application of behavior analytic methods.

In the past year, the pandemic has significantly affected us all and has been a major focus including employment and related personal matters. The SIG has supported other SIGs such as military/veteran's issues, crime and delinquency, including juvenile justice and prisons, and substance abuse.

Given the growth in the number of states with licensure bills in place and ongoing expansion of this process, our SIG can be a place for practitioners to share information

and discuss opportunities and strategies to promote the practice of behavior analysis as well as expansion of insurance coverage to areas outside of autism. Another issue of concern to many behavior analysts, among others, is the BACB's decision to discontinue its credentialing program outside of North America in 2023. Those in other countries who wish to practice behavior analysis have been active in online forums and social media to discuss their concerns, options and future of the profession of behavior analysis outside North America.

Rehabilitation and Independent Living

These individuals may also be dealing with complex, related medical conditions, intense psychosocial challenges, and significant disruption to their lives.

This SIG has the opportunity to be a gathering point for rehabilitation treatment professionals, including BCBAs, so they may compare program needs, treatment success and challenges, brainstorm innovative ideas, and help gather support to expand the field. Over the last 10 years in particular, the RAIL SIG has enjoyed participants from states across the US and from as far away as India, Canada, and Ireland. Unfortunately, with conferences and that are working on the practice of behavior analysis in areas meetings being held in a virtual arena for over a year, many participants have lost touch. The primary and consistently exciting event for the RAIL SIG has been the ABAI annual convention. The amazing discussions and plans that have been developed at that convention's meetings have suffered with the absence of an in-person opportunities.

Most members and active participants have been working diligently to pivot their practice and work to adjustments dictated by the COVID mandates and restrictions. The neurologically impaired population remained at great risk during the last year and the lockdowns were devastating to their mental recovery and ability to receive the vital treatment they needed.

The SIG continues to support expanding the understanding of brain injury and the need for behavior services. RAIL SIG members previously helped develop, with the BACB, a long-term action plan for growing the field of behavior analysis in acquired brain injury. This plan remains relevant however continued implementation has been difficult. As outlined previously, the plan described numerous areas of challenge, and key points needed to develop the field include increasing the number of faculty mentors and related opportunities to provide education on brain injury to behavior analysis students and collaborate on research projects. There remained a great need for practical training and supervision of students including internship opportunities and partnerships between current treatment programs and BCBA verified practicum programs. The SIG has outlined plans to present material and research to not just ABA conferences, but expand to other related professional conferences to promote the expansion of services. As the country opens post-COVID, it is the hope that more job opportunities in rehabilitation will be available, allowing the BCBAs to demonstrate their positive impact. Collaboration amongst treating BCBAs and other professionals will be vital to make this happen. Finally, as guidelines for behavior treatment in brain injury rehabilitation are being formulated under a program with the Brain Injury Association of America, research on interventions with brain injured patients is both limited and lacks clarity. More, well thought out research, is desperately needed.

The RAIL SIG has continued to welcome members from such diverse backgrounds as physicians and brain injury professionals to students and concerned family members. The power of that diversity is evident in lively discussions, informative exchanges of information and long-standing relationships that provide much needed support. Members are encouraged to share articles, program ideas and professional experiences. Members of the RAIL SIG must be a part of the solution. Growth of the RAIL SIG has come from current members networking with their peers and having the courage to step up to significant challenges this treatment population presents.
